On the basis of my review, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return:

- · has not been prepared in accordance with proper practices;
- that relevant legislation and regulatory requirements have not been met;
- is not consistent with the Council's/Committee's governance arrangements; and
- that the Council/Committee does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Other matters arising and recommendations

I draw the Council's attention to the following matters which do not affect my audit opinion but which should be considered by the Council.

Carried forward reserves

The Council has carried forward reserves of £41,044, compared to its annual precept of £12,500. Although the Council has identified £20,000 of these reserves as earmarked for capital expenditure the carried forward balances have been steadily increasing year on year and non-earmarked reserves now represent 168% of the Council's annual precept and 221% of the Council's total payments for the year. The Local Government Finance Act 1992 only allows the Council to set a precept to fund planned expenditure and requires it to take its reserves into account when setting the precept. To ensure that it sets a lawful precept, we recommend that the Council reviews its reserves and its plans to apply these reserves when setting its 2022-23 budget and precept.

There are no further matters I wish to draw to the Council's attention.
